

Foreword

2019 was undoubtedly Poland's year in the world of anti-doping. The main event that crowned several years of preparations was the World Conference on Doping in Sport, held on 5-7 November in Katowice. It was during this conference that Witold Bańka, Poland's Minister of Sport and Tourism was elected President of the World Anti-Doping Agency.

For the Polish Anti-Doping Agency, last year was a period of hard work during which we **launched a new anti-doping campaign entitled "Gramy Fair" (We Play Fair)**, promoted by a large number of famous ambassadors. To name a few, the **campaign was supported by Marcin Lewandowski, Monika Pyrek, Angelika Cichocka, Luiza Złotkowska and Joanna Jędrzejczyk.** 2019 was also the year of celebrating the **30th anniversary of the Polish anti-doping system.** Important records were broken: **the largest number of collected samples, a record number of hearings held by POLADA's independent Disciplinary Panel, and the largest number of anti-doping proceedings initiated.** We also established the POLADA Athletes Committee whose role is to support the Agency in its work and act as an advisory and opinion-making body.

The Analyses and Investigations Department of POLADA became fully operational. In cooperation with the Prosecutor's Office, the Police and other governmental agencies the Department conducted activities detecting violations of anti-doping rules and criminal law regulations relating to doping. Since its inception, over 100 doping-related investigations have been launched. The largest case cracked by the Department was the violation of anti-doping regulations by players of the second league football club Pogoń Siedlce. Two members of the coaching team and seven players were involved in the use of prohibited intravenous infusions. The case received a great deal of attention in Polish and foreign media.

In parallel with its domestic operations POLADA carried out international-level projects, in particular as part of the Agency's cooperation with the World Anti-Doping Agency, the Council of Europe, partners from international sports federations and national anti-doping organizations.







Education and information

Education is one of POLADA's core activities. In 2019, POLADA conducted educational activities addressed to athletes, members of national sports teams and all other participants of the sports movement. A total of 107 individual educational activities were carried out involving over 5 000 participants.



EDUCATIONAL ACTIVITY

Nearly half (44) of the educational actions in 2019 were carried out during training camps and consultations for sports teams, either at the national level or the province (country region) level. POLADA representatives also conducted educational actions in sports clubs, sports championship schools, during coaches' conferences, scientific conferences and championship-level sports events, such as the National Youth Olympic Games or ICF World Junior and U-23 Canoe Slalom Championships.

ANTI-DOPING CONFERENCES IN 2019

In 2019 POLADA hosted or co-hosted the following events:

- The World Conference on Doping in Sport, held in Katowice
- A conference marking the 30th anniversary of the Polish anti-doping system, entitled: "New challenges in the fight against doping in sport"
- The 6th National Conference on Sports Law, entitled: "Law, Sport, Finance 2019", organized by the Ius et Sport Academic Team on Sports Law, working under the aegis of the Warsaw University Faculty of Law and Administration
- The 6th Scientific and Educational Conference entitled "Pharmaceutical Crime: Detecting and Combatting – Practical Aspects", organized by the Police Academy in Piła.



Doping Control Program

The doping control program was implemented in line with the World Anti-Doping Agency's International Standard for Testing and Investigations and the Technical Document for Sport Specific Analysis (TDSSA). The statistics presented in the table refer to anti-doping tests conducted by the Polish Anti-Doping Agency in 2019, pursuant to the schedule and implementation requirements included in the 2019 annual doping control program.

In 2019, a total of 4 117 urine and blood samples were collected (1 810 in-competition and 2 307 out-of-competition). All the analyses were performed by the Polish Anti-Doping Laboratory in Warsaw. For the purpose of collecting the aforementioned samples, 555 control missions were performed across the country. The tests covered athletes representing 36 national sports associations.






Prohibited substances detected

In 2019, 32 more substances, metabolites or markers were detected than in 2018, and 62 more than in 2017 (76 substances in 2017; 106 substances in 2018; 138 substances in 2019). This indicates that more prohibited substances are used by individual athletes, mainly those competing in such sports as bodybuilding and fitness.



GRAPH: NUMBER OF PROHIBITED SUBSTANCES DETECTED, 2017-2019



Over the last 8 years, a total of 461 samples have been collected from athletes representing the Polish Bodybuilding, Fitness and Powerlifting Association. In 104 (22.5%) of the cases, anti-doping rule violations were discovered. Of greatest concern is the increasing number of anabolic androgenic steroids and diuretics detected.

Anti-Doping Rule Violations

In 2019, based on analytical evidence or non-analytical evidence, 65 proceedings (29 more than in 2018) were initiated with regard to anti-doping rule violations.

In 54 cases, anti-doping rule violations were found. In 11 cases it was concluded that the athletes in question were not at fault, or that there existed no grounds for imposing sanctions. Fourteen anti-doping proceedings initiated in 2019 were still pending in 2020.

Analytical evidence should be understood primarily as results of anti-doping laboratory analyses, whereas non-analytical evidence should be understood as any other form of evidence, such as documents, witness testimony or expert opinion. Nine anti-doping rule violations in 2019 were related to failure to provide whereabouts data or its incorrect entry into the monitoring system.








The Polish Anti-Doping Agency also carried out anti-doping testing on behalf of various entities, including international sports federations, elite sport event organizers and mass sports event organizers. In total, 69 control missions were conducted and 546 samples were taken.



International cooperation

In 2019, the Polish Anti-Doping Agency carried out a number of activities in the international arena. The main events from the POLADA international cooperation calendar are presented below.

KATOWICE WORLD CONFERENCE ON DOPING IN SPORT

The World Conference on Doping in Sport was held in Katowice on 5-7 November 2019. On the third day of the event, Polish Minister of Sport and Tourism Witold Bańka was officially approved as President of the World Anti-Doping Agency. His term of office commenced on 1 January 2020.

Apart from other items on the agenda, the conference included sessions of the WADA Executive Committee and WADA Foundation Board, during which amendments were approved to the World Anti-Doping Code - the agency's flagship document, and the international standards that constitute lower-level regulations. Together, these documents serve to harmonize global activities in the fight against doping. The new rules will enter into force on 1 January 2021.

The Athletes' Anti-Doping Rights Act was also approved at the conference. Unlike the Code, which is primarily about athletes' obligations, the Act regulates and supports athletes' universal right to clean and ethical sport based on the principle of fair play.

During the three days of the conference Katowice hosted nearly 1,600 representatives of the **Olympic movement, public authorities, anti-doping organizations, as well as athletes, experts in combating doping and journalists from around the world.** The event took place thanks to the cooperation of the World Anti-Doping Agency, the Ministry of Sport and Tourism, Katowice City Hall and the Silesia Province Marshall's Office.



COUNCIL OF EUROPE

POLADA together with the Ministry of Sport and Tourism (currently, the Ministry of Sport) actively participated in works of the Monitoring Group of the Council of Europe's Anti-Doping Convention. The main area covered by those activities was the analysis of the need to amend the text of the Convention in order to bring it into line with current needs and legal circumstances.

Moreover, the Polish Anti-Doping Agency supported the assessment of compliance with the Convention by individual member states of the Council of Europe. POLADA Director Michał Rynkowski participated in the evaluation team's two visits: to Croatia and to Italy, as chairman of the evaluation team.

For the first time ever, a joint visit together with the World Anti-Doping Agency was held. It was the visit to Italy, during which an audit on the country's compliance with the World Anti-Doping Program was conducted.

CEADO

On the initiative of the Hungarian Anti-Doping Agency HUNADO, representatives of the national anti-doping organizations of Austria, Croatia, Poland, Serbia, Slovakia, Slovenia and Hungary met in Budapest on 28 May 2019.

They made a joint decision to establish the Central European Anti-Doping Organization (CEADO). The meeting was also attended by representatives of the World Anti-Doping Agency, who participated as observers, and representatives of the Romanian Anti-Doping Agency which holds the status of an applicant organization.

CEADO, as an expert group that brings together the national anti-doping organizations of Central Europe, decided to take joint action to strengthen the member states' national anti-doping programs in the interests of all athletes who play clean sport. The group elected Michael Cepica, CEO of the Austrian Anti-Doping Agency, to serve as chairman of the CEADO board.



COOPERATION WITH THE UKRAINIAN ANTI-DOPING AGENCY

Cooperation between the Polish Anti-Doping Agency, World Anti-Doping Agency and Ukrainian Anti-Doping Agency, initiated in November 2018, continues to develop. Joint activities have resulted in the recognition of the Ukrainian Anti-Doping Agency as operating in compliance with WADA's World Anti-Doping Program. Achieving this goal required the development of appropriate regulations and

a change of Ukraine's anti-doping policy. POLADA's role has been to support our Ukrainian counterpart in the strengthening of their national anti-doping system by sharing our experience and good practices. All the activities are monitored by WADA and the Council of Europe. The cooperation is expected to end in late 2020.

iNADO

The Institute of National Anti-Doping Organizations has been broadly involved in the development of anti-doping policies and amendments to the World Anti-Doping Code, and in looking into the problem of doping in Russian sport.
