The year 2018 was the first full year of operation of the Polish Anti-Doping Agency. In that time POLADA has undertaken actions for the benefit of clean athletes and actions aimed at increasing the effectiveness of the fight against doping in sport. The Agency's

analytical and investigative division began its operation. In cooperation with the prosecutor's office, the police and other services, the division undertook activities aimed at detecting violations of anti-doping rules and criminal regulations concerning doping.


In 2018, a record number of doping controls on Polish athletes in the history of the Polish anti-doping system were conducted. The largest ever educational program was also implemented, which covered directly over 6,000 people. Apart from its activity on the national level, POLADA has also been active on the international arena. Cooperation with the Azerbaijani Anti-Doping Agency has been finalized. The Azerbaijani Agency is now able to independently run a national anti-doping program. In addition, the Ukrainian Anti-Doping Agency began to provide assistance in strengthening the anti-doping program in Ukraine, which focused mainly on creating optimal anti-doping rules. At the forum of the Council of Europe and

WADA, the exclusion of the Olympic team of Russia from participation in the Winter Olympics in Pyeongchang and the finalization of the investigation into the systemic practice of doping in Russia stirred a lot of emotions. In 2018, POLADA Director Michał Rynkowski was elected a member of the Management Board of iNADO (Institute of National Anti-Doping Organizations) and Vice-President of the Monitoring Group of the Anti-Doping Convention of the Council of Europe. POLADA has also undertaken joint activities with WADA in the area of implementation of the training on disciplinary proceedings, which was conducted in Tashkent for the Asian Regional Anti-Doping Organization.

EDUCATION AND INFORMATION

Thanks to an additional targeted grant from the Ministry of Sport and Tourism extended to POLADA in 2018, it was possible to undertake educational activities on an unprecedented scale. The priority in our activity was given to youth groups, thanks to which we reached out with anti-doping knowledge to numerous national teams of juniors and younger juniors, sports championship schools (SMS) and youth sports training centers (OSSM) and we were present on many arenas of the Polish junior championship and the National Youth Olympics.



In total, we conducted as many as 114 educational campaigns, in which over 6,000 athletes, coaches, doctors and sports activists participated.

Throughout the year, we displayed the "Gram Czysto - Fair Play" and the accompanying "Mistrzowski Anti-Doping" slogans during meetings with participants of the National Youth Olympic Games. The slogan "Zawsze Gram Czysto - Historia Prawdziwa" featured on banners containing graphics on the subject of combating doping was displayed in sports championship schools. There were 40 visits with lectures for female and male athletes and national team members in various sports disciplines (the vast majority were cadets and juniors), 28 educational actions took place in sports championship schools, 22 during the Polish Junior Championships and the National Youth Olympic Games, 13 lectures were conducted during training conferences

and meetings of officials, 5 in sports training centers for young people, 4 during training actions for regional staff and 2 in sports clubs.

Thirteen educational actions, the largest number ever, were conducted among the representatives of weightlifting; among others we visited all OSSM offering this sport. Representatives of athletics participated in 7 actions, representatives of canoeing in 6 actions, and representatives of handball and cycling in 5 actions. In addition, 4 actions were carried out for rugby players and wrestlers, 3 for rowing, judo, basketball, swimming, volleyball and ice hockey players, 2 for speed skaters and short distance skaters, skiers, tennis players, badminton, biathlon, table tennis, field hockey, fencing, boxing, and triathlon athletes and 1 each for athletes active in football, Olympic taekwondo, sports dance, kickboxing and sailing. In 2018, we continued to publish regular "Anti-Doping Reports" (28) and monthly newsletters for Polish sports associations.

The anti-doping banners mentioned above will remain a permanent feature of our activity. The banners were hung in 15 sports championship schools (Olsztyn, Oświęcim, Kraków, Duszniki Zdrój, Zielona Góra, Tychy, Zabrze, Wrocław, Łomianki, Szklarska Poręba, Racibórz, Poznań, Ostrowiec Świętokrzyski and Zakopane). There were also swimming

caps prepared jointly with Iguana Group Company and many other gadgets, which went to the participants of educational actions. Our activities have supported, among others, the representatives of Poland in volleyball and many young sportsmen.

In 2018, POLADA began preparations to launch a new anti-doping campaign "Gramy Fair – NIE dla dopingu", which in cooperation with the Ministry of Sport and Tourism, the Handball Association in Poland, PGNiG Superliga and other partners will be promoting fair-play among representatives of Polish sports in 2019 with a new impetus.



DOPING CONTROL PROGRAM

DOPING CONTROL MISSIONS AS PART OF THE NATIONAL DOPING CONTROL PROGRAM

The doping control program was implemented on the basis of the provisions of the International Standard for Testing and Investigations of the World Anti-Doping Agency and the Technical Document for Sport Specific Analysis (TDSSA). The statistics presented

All analyses were made by the Department of Anti-Doping Research at the Sports Institute in Warsaw. In order to collect the above mentioned samples, 539 control missions were carried out involving athletes representing 40 sports associations.










ANTI-DOPING RULE VIOLATIONS

On the basis of analytical and non--analytical evidence, 36 proceedings for anti-doping rule violations were instituted in 2018. analyses, whereas non-analytical evidence should be understood as any other evidence such as documents, testimonies or expert opinions.



In 34 cases, violation of anti-doping rules was found, while in 2 cases, the athlete was found not guilty or there was no basis for imposing sanctions. 5 proceedings in doping cases were continued in 2019. Analytical evidence should be understood primarily as the results of anti-doping laboratory








Anti-doping rule violations per sport

COOPERATION WITH THE AZERBAIJANI ANTI-DOPING AGENCY

In 2015 the World Anti-Doping Agency selected the Commission Against Doping in Sport to start cooperation with the emerging Azerbaijan Anti-Doping Agency in order to create the basis for the Azerbaijani anti-doping system. The Polish Anti-Doping Agency continued these activities in 2017. As part of the implementation of the supporting tasks, 13 meetings were held. They were conducted in accordance with the assumptions of an ambitious project plan agreed by both agencies and approved by WADA. The main objective of the plan was to achieve full operational capacity of the Azerbaijani Anti-Doping Agency in all areas of activity by January 2018. During



its implementation, three Steering Committee meetings were held: in December 2016 and March 2017. The role of the Polish Anti-Doping Agency was to share knowledge and experience in the implementation of the anti-doping control program, educational activities, investigations, organization and implementation of disciplinary proceedings concerning doping and proceedings for granting therapeutic use exemptions.

MICHAŁ RYNKOWSKI ELECTED VICE-PRESIDENT OF THE MONITORING GROUP

Michał Rynkowski, POLADA Director, was elected Vice-President of the Monitoring Group of the International Anti-Doping Convention of the Council of Europe. The decision was taken during the meeting held on 31 October 2018.

On 19 March 2018, during the general meeting of the iNADO (Institute of National Anti-Doping Agencies) members, Michał Rynkowski, POLADA Director, was elected a member of the iNADO Management Board. INSTITUTE OF NATIONAL ANTI-DOPING ORGANISATIONS

The main tasks of iNADO are to assist national anti-doping agencies in the development of anti-doping programs, analyze the current anti-doping situation and develop a global anti-doping system. Cooperation with the World Anti-Doping Agency and the sports movement is crucial for the organization. Currently, 70 national anti-doping organizations from all over the world are members of the organization.

COOPERATION WITH THE UKRAINIAN ANTI-DOPING AGENCY

In November 2018 the Polish Anti-Doping Agency, the World Anti-Doping Agency and the Ukrainian Anti-Doping Agency signed a trilateral cooperation agreement. POLADA's role is to support the Ukrainian partner in strengthening the national anti-doping system by sharing its experiences and good practices. All activities are monitored by WADA and the Council of Europe. The agreement was concluded for a period of 3 years.


RESULTS MANAGEMENT TRAINING FOR CENTRAL ASIA RADO
